Holiday Schedule Deadline for The Enterprise

NOTES:

1. Board of Appeals hearings are scheduled for the 2nd and 4th Thursday of the month. (Except in November, when one hearing is scheduled for the 3rd Thursday, and in December, when one hearing is scheduled for the 2nd Thursday.) Hearings will be held at 6:30 p.m. in the Main Meeting Room, St. Mary's County Chesapeake Building, 41770 Baldrige Street, Leonardtown, MD, 20650.
 2. There is no deadline date for Applications. However, all agency approvals, a complete application, and fee must be received prior to being scheduled on an agenda. (See current fee schedule.)
 3. Also, a heavy caseload may mean the next available agenda is several months into the future. Special hearings may be added to the schedule at the Planning Director's discretion.
 4. The legal ad must run a minimum of 15 days prior to the hearing date and will run in the ENT – Enterprise.
 5. Applicants must send notification letters to adjoining property owners and must post the subject property a minimum of 15 days prior to the hearing date.
