## 2018 Woman of the Year Award

### Nomination Form

Each year the St. Mary's County Commission for Women honors a **Woman of the Year** for her outstanding charitable, volunteer, and civic service to the local community.

#### **Awards presentation**

All nominees will be recognized at the Commission's annual **Women's History Month Banquet on March 15, 2018** at 6 p.m. at the Southern Maryland Higher Education Center, located at 44219 Airport Road, California, MD.

#### **Eligibility**

To be eligible for the Woman of the Year Award, the nominee must be a woman who:

- a) currently resides in St. Mary's County; and
- b) makes or has made a positive impact on the community through charitable, volunteer, or civic service.

Please note: paid work and employment are not eligible for consideration.

#### **Submitting nominations**

1. Notify the intended nominee and obtain their consent to be nominated.
2. Complete the attached Woman of the Year nomination form (Parts A and B).
3. Obtain a photo (digital preferred) of the nominee.

**1. Significant Contribution: Describe the nominee's exemplary services to individuals and/or non-profit organizations in St. Mary's County**

The judges are looking for a nominee who has taken the initiative to start special projects in her community that involve others, or has the possibility in the future of encouraging others to contribute (e.g. tutoring at-risk children, food drive for a shelter, park clean-up, etc.).

**2. Enthusiasm/Passion/Commitment: What makes this person stand out?**

The judges are looking for a nominee who possesses superior drive or determination.

**3. Leadership: How has the nominee motivated others to give their time to support organizations and/or individuals?**

The judges are looking for a nominee who assumes a leadership role in community activities, has the ability to inspire others and generate enthusiasm, and/or leads with her actions in ways such as volunteering, expressing individuality and being a diligent worker.

**4. Impact: What impact has the nominee's community service had in St. Mary's County this year?**

The judges are looking for a nominee who has made a significant positive contribution to the local community.
