ONLINE PAYMENT

Pay **online** using the following payment methods: Debit card, American Express, Visa, Mastercard, Discover, or a checking account. There are no additional fees when paying by direct transfer from a checking account. However, a convenience fee of 2.5% is charged for the use of a credit card or a debit card and will appear as a separate line item on your banking or credit card statement.

A receipt for payment will be emailed to you within 24 hours. Your confirmation number is available for you immediately.

Please note that all online and phone payments need to be received by midnight Eastern Standard time on any given deadline.

PHONE PAYMENT

Pay by phone by calling toll free 833-424-0200. Acceptable payment methods: Debit card, American Express, Visa, Mastercard, Discover, or a checking account. There are no additional fees when paying by direct transfer from a checking account. However, a convenience fee of 2.5% will be charged for the use of a credit or debit card. These fees will appear as a separate line item on your banking or credit card statement.

Please note that all online and phone payments need to be received by midnight Eastern Standard time on any given deadline.

MAIL PAYMENT

Pay by mail with your remittance coupon and using the address below. Checks should be made payable to the St. Mary's County Treasurer and include your name, address, phone number and account number found on the remittance coupon of your tax bill.

The postmark on your mailed envelope is honored as the payment date of your payment. Please go to the post office and request to see the stamped postmark date when a deadline is near to verify the date of the postmark on your envelope.

ONLINE BILLPAY

Pay using your bank's personal Online Bill Pay system. However, taxpayers using this option should be aware of the following:

- Once you complete the bill pay process on your bank's website your bank may not submit payment to the Treasurer's Office immediately. Allow additional time for this delay to avoid penalty and interest charges.
 - You must enter the appropriate mailing address: St. Mary's County Treasurer, P.O. Box 642, Leonardtown, MD 20650.
 - Your payment should be made payable to the St. Mary's County Treasurer.
 - In the memo or account section put the parcel account number found on the remittance coupon of your tax bill to allow for accurate credit of your payment.

MORTGAGE ESCROW

Real residential and commercial property taxes may be paid by a financial institution holding the mortgage on the property through an escrow account. If you have further questions about paying through escrow, please contact your mortgage company.

MULTIPLE ACCOUNT/ESCROW PAYMENT
